13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. It is intended to alter the surface casing depth and cement of the subject well. A 9 7/8" hole will be drilled to 120'. 7" 20# J-55 casing will be run to 120'. It will be cemented with 27 sacks Class A, B Portland Type I, II cement (32 cu. ft. of slurry, ~~bringing cement to surface through 3/4" line~~).
