MIRU Key Energy #47. Spud 12-1/4" hole @ 2000 hrs 4/3/01. Drilled ahead to 305'. Circ. hole. RIH w/8-5/8", 24#, J-55 casing and set @ 300'. RU to cement. Pumped a preflush of 10 bbls mud clean, 10 bbls dye water ahead of 200 sx (280 cf - 49.86 bbl slurry) Type 3, 2% CaCl2, 0.25#/sx Cello-flake. Displaced w/17.5 bbls H2O. Plug down @ 0600 hrs 4/4/01. Circ. 10 bbls cement to surface. WOC. NU WH & NU BOP and manifold. PT - OK. Trip in hole to 270'. PT pipe rams and casing to 200 psi low and 2000 psi high for 30 minutes. Good test.
