5/5/01 MIRU Key Energy #47. Spud 12-1/4" hole @ 1900 hrs 5/5/01. Drilled ahead to 340'. Circ. hole. RIH w/9-5/8", 32.3#, H-40 casing and set @ 338'. RU to cement. Pumped a preflush of 10 bbls mud clean, 10 bbls dye water and then pumped 220 sx (310 cf - 55.20 bbl slurry) Type 3, 2% CaCl<sub>2</sub>, 0.25#/sx Cello-flake. Displaced w/24 bbls H<sub>2</sub>O. Plug down @ 0704 5/6/01. Circ. 10 bbls cement to surface. WOC.

NU WH, NU BOP, PT BOP, rams, manifold and casing to 200 psi and then 1500 psi - 30 minutes. Good test.
