Pumped a preflush of 10 bbl water, 10 bbls mud clean, 10 bbls dye water ahead of Lead - 450 sx (1085 cf - 193.27 bbl slurry) Premium Lite High Strength FM, 3#/sx CSE, 3% KCL, 0.25#/sx Cello-flake, 0.4% FL-25, 4#/sx Pheno-seal, 5#/sx LCM-1. Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl<sub>2</sub>, 0.25#/sx Cello-flake. Displaced w/136 bbls water. Plug down @ 0515 hrs 10/22/02. Circulated 5 bbls cement to surface. ND BOP, set slips. PT BOP, rams, manifold and casing to 200 psi low and 2000 psi high. Good test.
