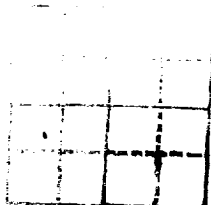

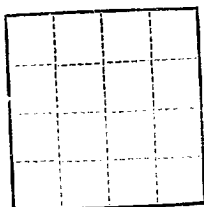

DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesa Verde drilling the pay section with gas circulation, and to sand-oil the Cliff House and Point Lookout formations. Total Depth 5630'.

7" at 4890' with 250 sacks Pozmix and 250 sacks regular cement.
