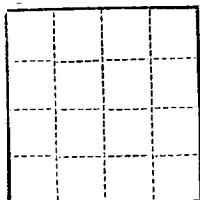

DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde formation, drilling the Mesaverde with gas circulation, and to shoot the entire pay with 2 quarts of S.N.G. per foot. Total depth 5460'.

Casing Program:

9-5/8", 36#, J-55 casing at 170' with 125 sacks of cement circulated to surface.

7", 20#, & 23#, J-55 casing at 4675' with 500 sacks of regular cement.

The E₂ of Section 30 is dedicated to this well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
