13. Describe Proposed or Completed Operations

It is intended to recomplate the Fruitland Coal formation in the subject well as follows:

Pull pump and rods. Pull tubing. Set a cast iron bridge plug at approximately 3100'. Run a cement bond log across the Fruitland Coal interval. Perforate Fruitland Coal at approximately 2875-3075'. Fracture treat perforations with linear gel and foam in two stages. Flow back and clean up after stimulation. Drill out cast iron bridge plug and clean out well to plug back total depth. Land tubing at approximately 5650'. Reinstall pump and rods. Return well to production. The well will be commingled. A down hole commingle application will be submitted.
