Cmt d w/215 sx Class "B" neat cmt w/3% calcium chloride, 0.25 pps Flocele (247 cu.ft.). Circ 12 bbl cmt to surface. WOC. NU BOP. PT BOP & csg to 600 psi/30 min, OK. Drilling ahead.

8-16-97 Drill to TD @ 3292'. Circ hole clean. TOOH. TIH to log.

8-17-97 Log well. TOOH. TIH, drill from 3292' to TD @ 3320'. Circ hole clean. TOOH. TIH w/13 jts 3 1/2" 9.2# J-55 csg, 76 jts 3 1/2" 7.7# WC-70 csg, set @ 3309'. Cmt d w/383 sx Class "B" 65/35 poz w/6% gel, 0.5 pps Flocele, 10 pps Gilsonite (709 cu.ft.).
