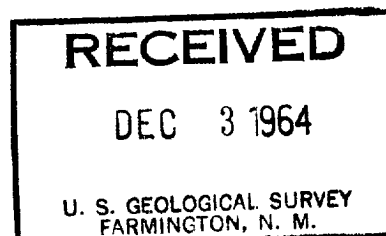

Drilled 5-1/4" hole from original T.D. of 5350' to T.D. of 7555'. Ran 233 jts. of 4-1/2" OD 11.6 and 10.5 J-55 casing landed at 7555'. Cemented in three stages with stage collars @ 5454' and 4470'. 1st stage 100 sks. cement, 2nd stage 175 sks. cement and 3rd stage w/270 sks. cement. Cement bond log indicated top of cement @ 1850'. Cemented top of 4-1/2" casing through perforation @ 1800' with 140 sks. Class C cement. Drilled cement and cleaned out to PSTD of 7535', tested casing to 4000 PSI; held OK. Now preparing to perforate and frac.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
