The subject well was temporarily abandoned on 10/24/2002. Sundry Notice was submitted on 10/30/2002, however, we failed to note that it was our intent to hold the well for possible recompleat into the Fruitland Coal formation. An evaluation of the economic feasibility of recompleat into the Fruitland Coal is in the process and a determination concerning this wellbore should be made shortly. Should the evaluation indicate that recompleat is not feasible we would like to maintain the well as a pressure monitoring well for the Fruitland Coal formation.
