- 1. Hold safety meeting. Comply with all NMOCD, BLM and Burlington safety and environmental regulations. Test rig anchors and build blow pit prior to moving in rig. Notify BROG Regulatory (Peggy Bradfield 326-9727) and the appropriate Regulatory Agency prior to pumping any cement job. If an unplanned cement job is required, approval is required before the job can be pumped. If verbal approval is obtained, document approval in DIMS/WIMS. Allow as much time as possible prior to pump time in case the Agency decides to witness the cement job.
- 2. MOL and RU workover rig. Obtain and record all wellhead pressures. NU relief line. Blow well down and kill with 2% KCL water if necessary. Set plug in MV tubing. ND WH and NU BOP with stripping head. Test and record operation of BOP rams. Have wellhead and valves serviced as necessary. (A single-tubing donut and WH for 2-3/8" tubing will be needed.) Test secondary seal and replace/install as necessary.
- Pictured Cliffs 1-1/4" tubing is set at 3070'. TIH with 1-1/4" tubing, tag for fill on top of packer. If fill on packer, TOOH and lay down orange peel. TIH, clean off packer. TOOH laying down 1-1/4" PC tubing. Mesaverde 2-3/8" tubing is set at 5571'. Pick straight up on 2-3/8" MV tubing to release the Baker Model "G-22" seal assembly from the Baker Model "F" packer. TOOH with 2-3/8" tubing and D seal assembly. Visually inspect tubing for corrosion and replace any bad joints. Check tubing for scale build up and notify Operations Engineer.
- 4. TIH with 2-3/8" tubing and Baker Model "CJ" packer milling tool to recover the Baker Model "F" packer. Mill on packer with air/mist (using a minimum mist mist rate of 12 bph). TOOH and lay down packer
- 5. TIH with 3-7/8" bit, bit sub, and watermelon mill on 2-3/8" tubing and round trip to PBTD, cleaning out with air/mist (using a minimum mist mist rate of 12 bph). Contact Operations Engineer if it is necessary to remove scale from the casing and perforations. PU above perforations and flow the well naturally, making short trips for clean up when necessary. TOOH laying down bit, bit sub and watermelon mill.
- 6. TIH with 2-3/8", 4.7#, J-55 tubing with a notched expendable check on bottom, F-Nipple (one joint off bottom), then ½ of the 2-3/8" tubing. Run a broach on sandline to insure that the tubing is clear. TIH with remaining 2-3/8" tubing and then broach this tubing. Replace any bad joints. CO to PBTD with air/mist (using a minimum mist rate of 12 bph).
- 7. Land tubing at ±5540'. ND BOP and NU single-tubing hanger WH. Pump off expendable check. Obtain final pitot gauge up the tubing. Connect to casing and circulate air to assure that the expendable check has pumped off. If well will not flow on its own, make swab run to F-Nipple. RD and MOL. Return well to production.
