TIH w/csg cutter & cut csg @ 4137'. Set 150 Sx class "B" cement from 3243'-4137'. WOC 12 hrs. Drill 4 3/4" rathole from 3728'-3748' w/no angle, & 3748'-3766' w/4 1/4° angle. Clean hole to 3766'. Resume drilling.
