Dear Ms. Staley:

Reference is made to your application dated September 15, 1998, which was received by the New Mexico Oil Conservation Division ("Division") in Santa Fe on September 18, 1998, for an exception to the well location requirements provided within the "*Special Rules and Regulations for the Blanco-Mesaverde Pool*," as promulgated by Division Order No. R-10987, for a non-standard gas well location in an existing standard 320-acre stand-up gas spacing and proration unit for the Blanco-Mesaverde Pool comprising the E/2 of Section 22, Township 29 North, Range 8 West, NMPM, San Juan County, New Mexico. This unit is currently dedicated to Amoco Production Company's: (i) Roelofs "B" Well No. 1 (API No. 30-045-08091), the initial well on this unit, located 990 feet from the North line and 2310 feet from the East line (Unit B) of Section 22; and, (ii) Roelofs "B" Well No. 1-A (API No. 30-045-22720), located at a standard infill gas well location 1180 feet from the South line and 1100 feet from the East line (Unit P) of Section 22.

The application has been duly filed under the provisions of Division Rules 104.F and 605.B of the General Rules and Regulations of the New Mexico Oil Conservation Division ("Division").

By the authority granted me under the provisions of Division Rule 104.F(2), the following described well to be drilled at an unorthodox gas well location in Section 22 is hereby approved:

**Roelofs "B" Well No. 1-B  
2440' FNL & 1350' FEL (Unit G).**

Further, Amoco Production Company is authorized to dedicate Blanco-Mesaverde gas production on the subject unit from the proposed Roelofs "B" Well No. 1-B with the two existing Roelofs "B" Well Nos. 1 and 1-A. These three wells and the existing 320-acre unit will be subject to all existing rules, regulations, policies, and procedures applicable to prorated gas pools in Northwest, New Mexico.



Amoco Production Company hereby requests administrative approval for an unorthodox well location for the Roelofs B #1B well in the Blanco Mesaverde Pool. Amoco plans to drill this well at an unorthodox location as a third well in the existing spacing unit to access reserves which would otherwise be bypassed with the current well density. This well, as proposed, would be moving toward the center line of the spacing unit only and would be well within the standard 790 foot setback from the outer boundaries of the spacing unit. We are locating this well toward the center of the spacing unit, away from the parent and original infill, which would cause it to fall outside the traditional drilling windows for the Blanco Mesaverde Pool.

A copy of this application will be submitted to the offset operators by certified mail with a request that they furnish your Santa Fe office with a Waiver of Objection, and return one copy to this office. Attached are plats showing the location of the well, offset operators, and all wells drilled in the area.

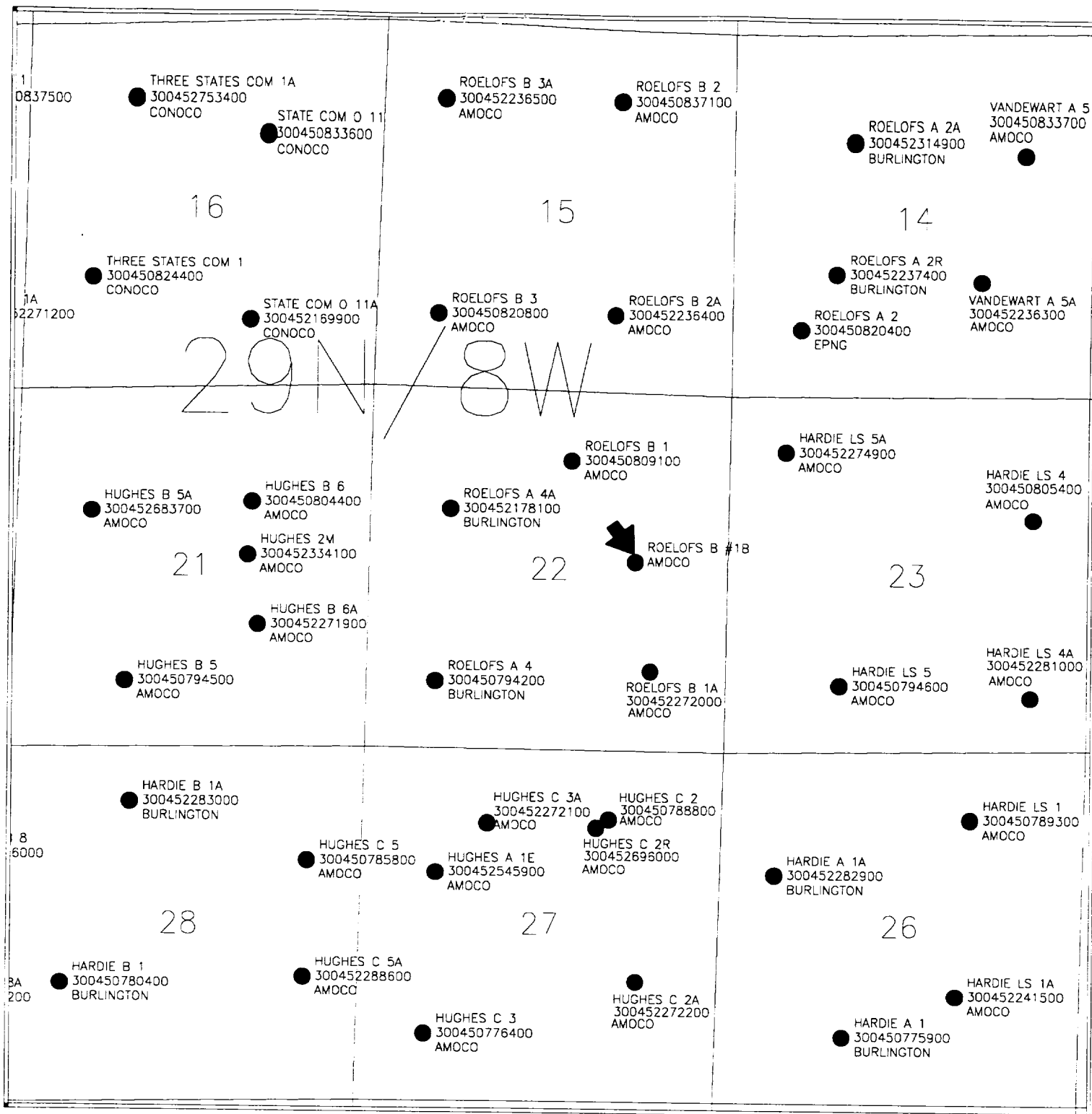
