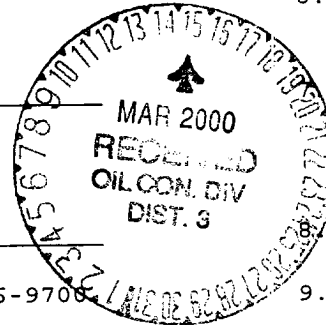

2-10-00 Drill to intermediate TD @ 3145'. Circ hole clean. TIH w/76 jts 8 5/8" 32# J-55 ST&C csg, set @ 3144'. Cmdt w/460 sx Class "B" neat cmt w/ 3% econolite, 10 pps gilsonite, 0.5 pps flocele (1339 cu ft). Tail w/110 sx Class "B" 50/50 poz w/2% gel, 10 pps gilsonite, 2% calcium chloride, 0.5 pps flocele, 0.2% CFR-3 (149 cu ft). Circ 80 bbl cmt to surface. WOC.

2-11-00 NU BOP. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
