On 6-5-69 T.D. 3092', ran 100 joints 2 7/8", 6.4#, J-55 casing (3092') set at 3092' w/155 sacks of cement. W.C.C. until completion.

On 7-9-69 P.B.T.D. 3092', perf. 3034-50' w/2 SFF. Sand water frac w/28,000# 10/20 sand, 27,480 gal. water, flushed w/800 gal. water. Box ball drop.
