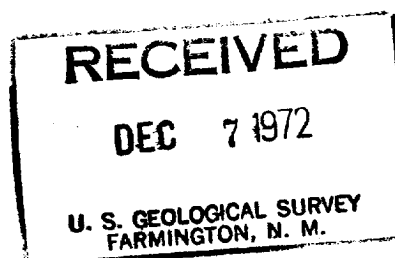

The well was drilled to a TD of 2485' and on November 15, 1972, the 4-1/2" casing was set at 2472' with 300 sacks Class "C" 50-50 Pozmix with 6% Gel and 2 pounds Tuf Plug per sack followed by 75 sacks Class "C" Neat. The cement did not circulate.

Instructions
