

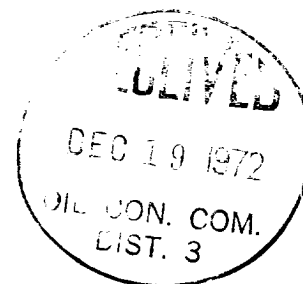

A 6-3/4" hole was drilled to a total depth of 2275' with the 4-1/2" casing set at 2259'. The casing was cemented December 16, 1972 with 400 sacks 50-50 Class "C" Foxmix with 6% Gel and 2 pounds Tuf Plug per sack followed by 75 sacks Class "C". The cement circulated.
