Dear Mr. Sagle:

During a visit to the Santa Rosa 7 #1 well site on November 21, 1997, some environmental and safety problems were discovered. The currently operating well site compressor is leaking crankcase oil and lube oil to the ground. The out-of-service compressor, which is still in place, has had a similar history as indicated by oil stains surrounding the unit. Due to the shallow groundwater at this site, SG Interests I Ltd. is directed to remove both units and excavate the non-exempt oil field contamination. If groundwater is encountered, it will be sampled for BTEX and ICAP metals with mercury and selenium by AA.

Final disposition of contaminated materials will be based on volumes and impact on the groundwater. Smaller volumes lend themselves to on-site remediation. The well site compressor may continue to operate with some type of containment for leaking oils and wash down water. Something as simple as rails and a catchment, which will be periodically emptied, may suffice.

SG Interests I Ltd. will notify Denny Foust or Johnny Robinson of the Aztec District Office a minimum of 24 hours before initiating excavation so the operation may be witnessed. SG Interests I Ltd. will submit a written plan and drawings for containment on the compressor installation.

The production tank has a profusion of weeds growing next to it which constitutes a fire hazard. SG Interests I Ltd. will remove the weeds.

SG Interests I Ltd. has until January 15, 1998, to initiate these operations and have them completed by January 31, 1997.



Excavation and clean up operations of oil-stained compressor sites on the Santa Rosa #7-1 well will take place January 20, 1998 at 9:00 AM.

A drawing of a containment "pan" is attached. Our plans are as follows:

- -build containment pan as shown on attachment
- -move Santa Rosa 7-1 compressor into pan
- -excavate contaminated soil at two sites on 7-1 location.

Operations to remove weeds near the production tank are complete. The out-of-service compressor has been removed.
