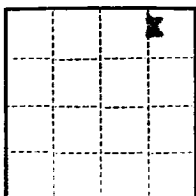

## DETAILS OF WORK

It is intended to drill a well with rotary tools through the Mesaverde, drilling the pay with gas circulation, and to shoot the entire Mesaverde with two quarts S.M.G. per foot. Total depth 5530'.

9-5/8" at 160' with 125 sacks regular cement circulated to surface.

7 " at 4588' with 300 sacks regular cement.

The NE ¼ of Section 15 is dedicated to this well.
