This is a request for administrative approval for an unorthodox gas well location in the Undesignated Fruitland Pool.

It is intended to locate El Paso Natural Gas Company San Juan 30-6 Unit #409 at 2265' from the South line and 715' from the West line of Section 25, T-30-N, R-7-W, Rio Arriba County, New Mexico.

Extremely rough terrain in the form of steep cliffs makes it impossible to build an orthodox location in the Southwest quarter of this section.

El Paso Natural Gas Company is the Unit Operator of the San Juan 30-6 Unit.

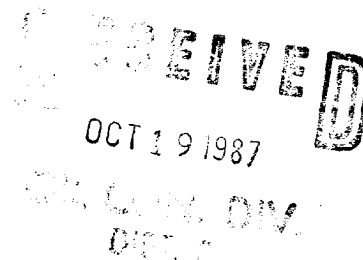
