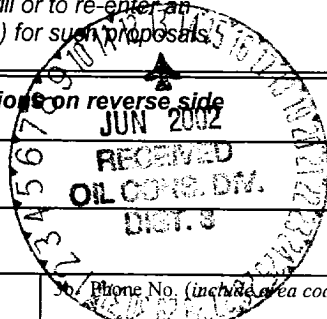

It is intended to Add the Fruitland Coal and downhole commingle it with the Pictured Cliffs under NMOCD Order # R-11363 as follows:

1. MIRU. TOH and lay down tubing.
2. Set CIBP at 4275'. Test casing to 3000 psi.
3. Selectively perforate Fruitland coal and fracture treat.
4. Flow back frac. TIH and clean out to PBTD with air mist.
5. Run 2 3/8" tubing. Run pump and rods. Install pumping unit and return to production.
