13. Describe Proposed or Completed Operations

DHC-2641 was approved to commingle the La Jara Pictured Cliffs and the Blanco Mesaverde pools.

It is now intended to drill and complete the subject well in the Blanco Mesaverde (Pool Code 72319) and the Basin Dakota (Pool Code 71599). These zones will then be dualled with the Pictured Cliffs. The production will be commingled according to Oil Conservation Division Order Number 11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. Bureau of Land Management has been notified in writing of this application.

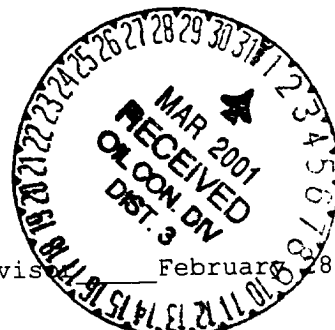
Notification of the intent to commingle the subject well was sent to all interest owners via certified mail on February 6, 2001. No objections were received.
