Dear Mr. Gorham:

We are as of this date approving Notice of Intention to Drill on your #25 State well in the SW $\frac{1}{4}$  Section 36-29N-11W. We note, however, that the acreage in the SW $\frac{1}{4}$  totals 157.24 acres. This well is within one mile of the Fulcher-Kutz Pool boundaries and is therefore governed by Order R-565-C. Rule 6-A of Order R-565-C states that a standard proration unit shall contain between 158 and 162 acres. Rule 6-B stipulates that the Secretary of the Commission shall have authority to grant exception without notice and hearing in situations such as yours.

We are enclosing a memorandum setting out the proper procedure for you to follow to secure administrative approval of this non-standard unit. This approval must be secured before a Form C-110 can be approved.

Figure 6 shows the results of the regression analysis. The model explains 70% of the variance in the dependent variable ( $R^2 = .70$ ). The adjusted  $R^2$  value is .68. The F-statistic is 19.45, which is significant at the .001 level. The t-statistics for the coefficients are also significant at the .001 level.
