3. Rotary tools will be employed from surface to T.B. pipe will be set at approx. 6500'.
4. Run 4 1/2" stage collar set below Picture Cliff Formation. Cemented w/100 sacks.
5. Estimated T.B. 6500 feet.
6. The well will be sand fracked in an effort to stimulate production.

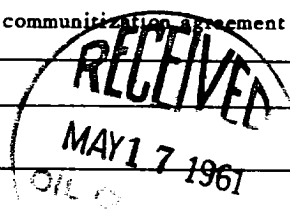

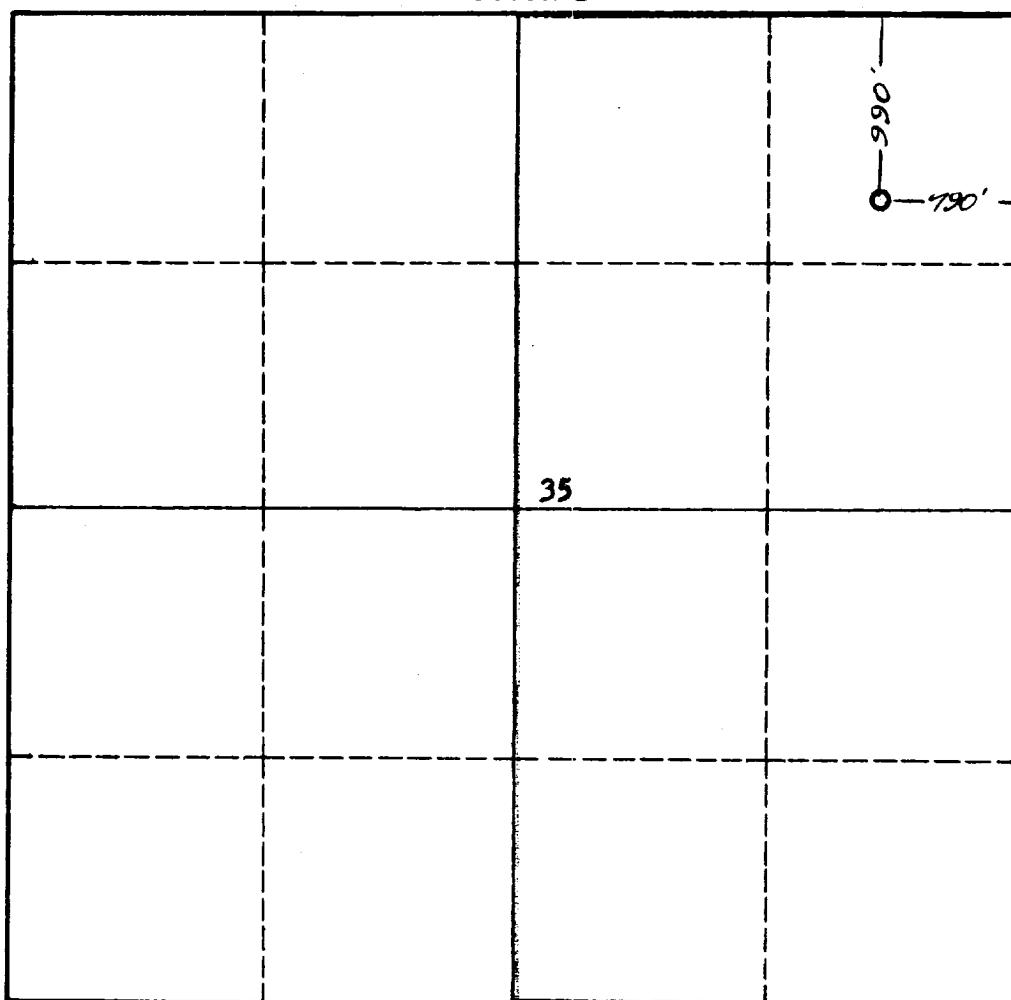
