DETAILS OF WORK

We propose to drill subject well as follows:

1. Drill 11" hole to 150'. Run and cement 8-5/8" casing and set at 150'. Cement with sufficient volume to circulate to surface. WOC 12 hours and pressure test casing after WOC 8 hours.
2. Drill 7-7/8" hole to TD approximately 5650'. Run BB-Resistivity and Gamma Ray Sonic logs.
3. Run 4-1/2" OD, 9.5#, J-55, STAC casing through deepest pay and cement with 100 sacks cement. Set stage collar 50' below base of Pictured Cliff and cement with 50 sacks cement.
4. Release rig, pressure test casing, run tubing, recover load oil, potential well and clean location.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

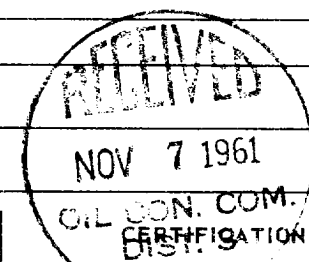
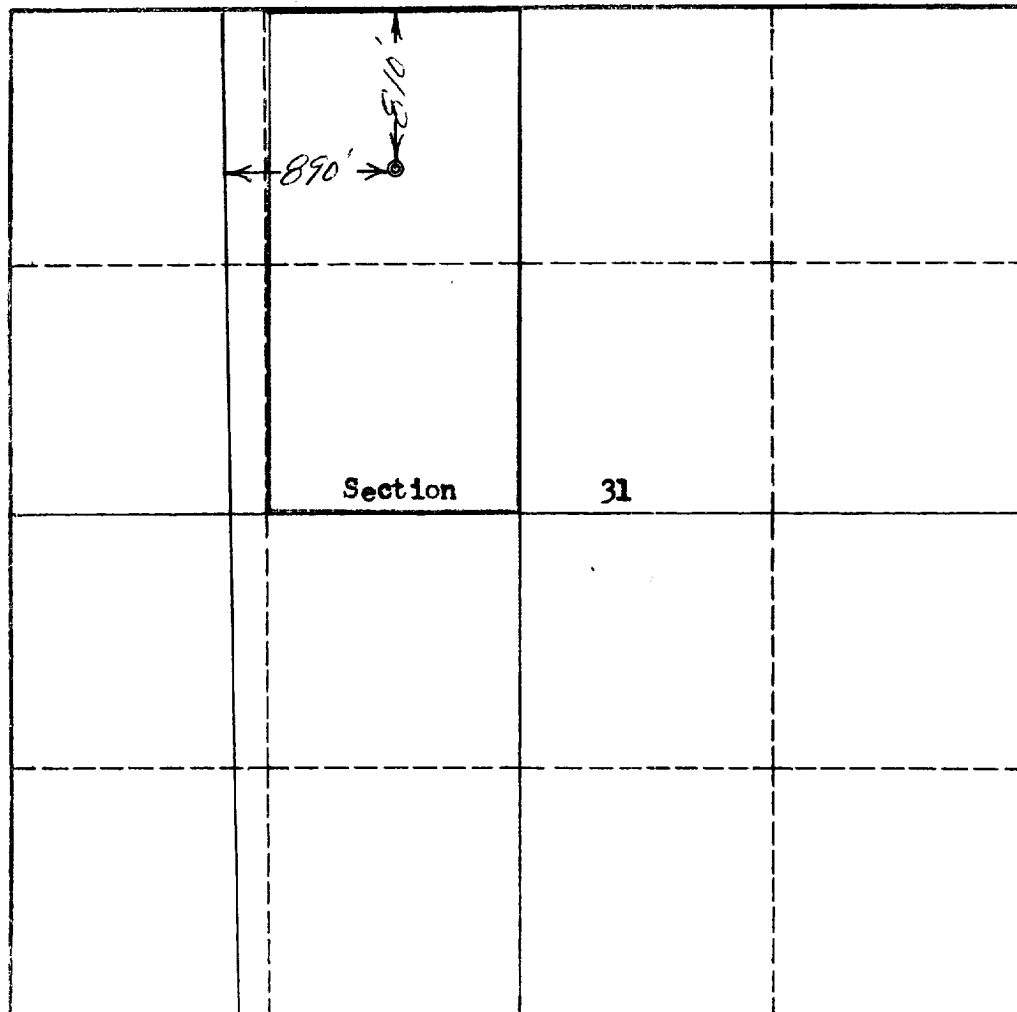

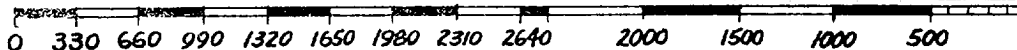
