
- 1) RIH, set CIBP at 5450' w/30 sx Class G Neat cement plug to 5107', 50' above Gallup top at 5157'.

- 3) Set 36 sx Class G Neat plug from 1500-1400' inside and outside casing. Picture Cliff top at 1450'.
- 4) Set 36 sx Class G Neat plug from 1174-1074' inside and outside casing. Fruitland top at 1124'.
- 5) Set 73 sx Class G Neat plug from 259' to surface inside and outside casing from 50' below casing shoe at 209'.
