THE APPLICATION OF PAUL CASE
FOR PERMISSION TO EFFECT DUAL
COMPLETION OF ITS SULLIVAN WELL
NO. 4, LOCATED IN THE NW/4 SW/4
OF SECTION 25, TOWNSHIP 29 NORTH,
RANGE II WEST, NMPM, SAN JUAN COUNTY,
NEW MEXICO, IN SUCH A MANNER AS TO
PERMIT THE PRODUCTION OF GAS FROM
THE PICTURED CLIFFS FORMATION
ADJACENT TO THE FULCHER KUTZPICTURED CLIFFS POOL AND THE
PRODUCTION OF GAS FROM THE AZTEC
FRUITLAND POOL.

ADMINISTRATIVE ORDER OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) Paul Case made application to the New Mexico Oil Conservation Commission on November 10, 1958, for permission to dually complete its Sullivan Well No. 4, located in the NW/4 SW/4 of Section 25, Township 29 North, Range II West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Pictured Cliffs formation adjacent to the Fulcher Kutz-Pictured Cliffs Pool and the production of gas from the Aztec Fruitland Pool.

Now, on this 28th day of November, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Subsection 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, Paul Case, be and the same is hereby authorized to dually complete its Sullivan Well No. 4, located in the NW/4 SW/4 of Section 25, Township 29 North, Range Il West, NMPM, San Juan County, New Mexico, in such a manner as to permit the production of gas from the Pictured Cliffs formation adjacent to the Fulcher Kutz-Pictured Cliffs Pool and the production of gas from the Aztec Fruitland Pool, through the tubing and the casing-tubing annulus respectively.

PROVIDED HOWEVER, that applicant shall complete, operate, and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order R-1214.

PROVIDED FURTHER, that applicant shall take packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Fulcher Kutz-Pictured Cliffs Pool.
