1. MI&RU Completion rig 10-4-94.
2. Drilled out to PBTD 5447'. Set plug at 5330'. Dumped sand on top of plug and pumped 10 bbls. water.
3. Set packer at 3132'. Western squeezed hole in casing at 3806' w/47 sx Class B Neat cement to 1000#.
4. Set packer at 2877'. Squeezed hole in casing at 3036' w/143 sx Class B Neat cement to 900#, held okay.
5. POH w/tubing and packer. Pressured up on casing to 700#, held okay.
6. RIH w/tubing and bit. Tagged cement at 2676'; drilled out to 3880'. Circulate hole clean. POH w/plug.
7. RIH w/tubing and packer. Set packer at 2910', tubing at 5010'. Released rig 10-11-94.
