Gerk Gas Unit Well No. 1. On November 29, 1958, ran 5-1/2" casing liner with Baash Ross lead seal hanger set at 2292 - 4524' with 250 sacks 6% gel cement with 1-1/2 pound Tuf Plug per sack. Preceded cement job with 20 barrels light gel mud. Set lead seal and reversed out trace mud and no cement. Top cement 3480' by temperature survey. After waiting on cement, tested casing liner with 1750 pounds pressure, which held with no drop in pressure.
