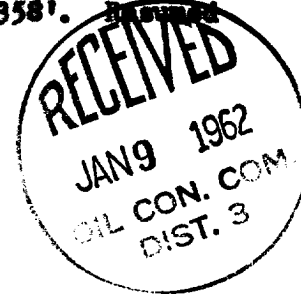

Spudded 12-1/4" hole December 27, 1961. Set 8-5/8" casing at 358' with 220 sacks Incon cement containing 2 percent Calcium Chloride. Circulated 10 sacks of cement. After waiting on cement, tested 8-5/8" casing with 800 psi for 30 minutes, which held with no indication of pressure drop. Reduced to 7-7/8" at 358'. Resumed drilling operations.
