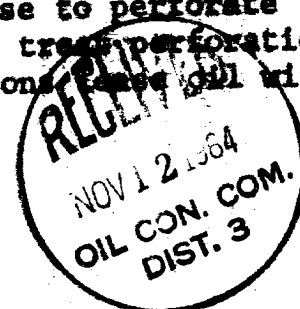

Instructions
