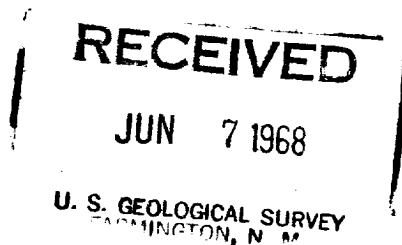

Set retrievable bridge plug at 2300'. Pumped fresh water in to clean up. Pumped in 400 sacks 50-50 Pozmix cement with 2% gel, displaced with 18 barrels of water. Let set 24 hours, drilled cement and cleaned out to 4721'. Tested casing at 800#, held ok. Ran tubing and rods. Pump tested for 11 BO & 56 BWPD.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
