Dear Mr. Greer:

I have a letter from you dated June 11 with a surveyor's plat of J. R. Sharp, Luthy No. 2. I must remind you that it is necessary that a plat of the proposed unorthodox location show the offset owners, and, if they are not the same as the lessee of the drilling unit in question, their written permission must be given for the unorthodox location. Further, in this particular case, the plat does not make it clear why the 1490-foot dimension could not be 1650 feet. This would be a regular 330 location and would not necessitate unorthodox permission.

Enclosed also you will find a letter dated April 16 which is self-explanatory. I have never received the necessary letters nor the offset permission for this well, which I notice by the scout report is practically a completed well.

In the future you will not approve an unorthodox location, and I will only approve an unorthodox location when the file is complete with offset permission, plats, etc.

Copy of this letter is going to Mr. Harvey, and he will not be allowed to produce this well until the unorthodox location is approved.
