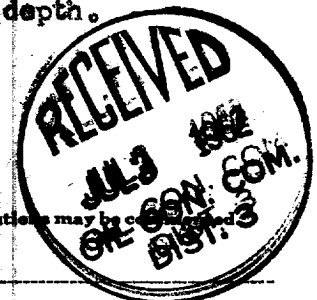

DETAILS OF WORK

We propose to drill this well with rotary tools to an estimated depth of 6700' to test the Paradox Formation. Approximately 300' of 13 3/8" surface casing will be run and cemented to surface. Approximately 4600' of 9 5/8" intermediate casing will be run and cemented. A stage collar will be located at approximately 1000' to cement the Dakota Formation. A 7" O. D. liner will be set and cemented from approximately 4600' to 6600'. The well will be completed open hole from the bottom of the liner to total depth.



I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

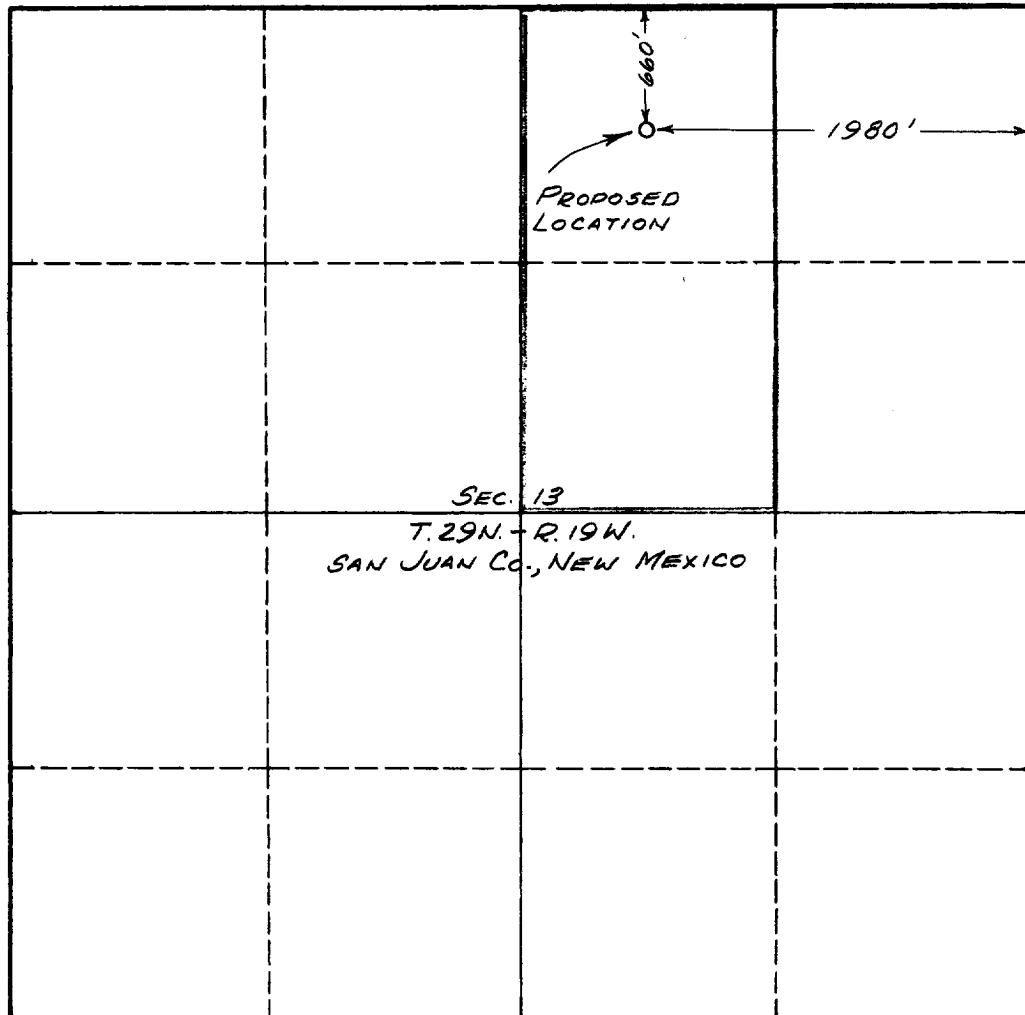

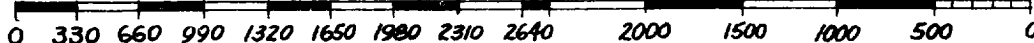
