

3. That the proposed non-standard proration unit consists of contiguous quarter-quarter sections, or lots.

4. That the proposed non-standard gas proration unit lies wholly within Section 18, Township 29 North, Range 10 West, N.M.P.M., San Juan County, New Mexico.

5. That a non-standard gas proration unit allowing less than 160 acres as required by the provisions of Order No. R-565 is necessitated solely by a variation in the governmental survey of said Section 18, Township 29 North, Range 10 West, N.M.P.M., and unless allowed by the Commission, applicant will be deprived of his opportunity to recover his fair and equitable share of the gas in said pool, contrary to law.

6. That in the opinion of the applicant the entire proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.

7.
