Place 25 sacks cement over and squeeze small amount into perforations 4,111-16'.

Cut 4 1/2" casing at approximately 3,200' and pull.

100' plug across 4 1/2" casing stub with 25 sacks.

100' plug 725-825'.

15' surface plug with regulation marker.

Intervals between plugs will be filled with mud, location cleaned and pits filled.
