In accordance with New Mexico Oil Conservation Commission Order No. FMX-14 dated February 25, 1965, Navajo Tribal "H" No. 12 was converted to water injection on April 10, 1965 as follows:

1. Hot oiled casing annulus and pumped back load oil.
2. Moved in and rigged up pulling unit and pulled rods and pump.
3. Ran casing scraper on tubing, and circulated hole clean with oil.
4. Displaced oil with treated water and pulled tubing.
5. Ran 2-3/8" tubing with Baker packer set at 4838'.
6. Hooked up to injection system and started injecting water down tubing into Gallup Zone on April 10, 1965.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
