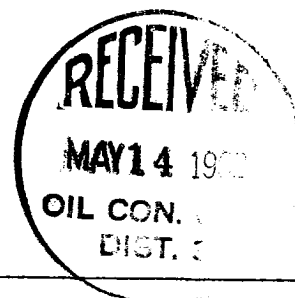

On May 1, 1962 the above well was spudded and drilled to a depth of 373'. 8 5/8" casing was set at that depth and cemented with 230 sacks Inco cement containing 2% calcium chloride. Cement circulated. After waiting on cement, tested casing with 400 psi for 30 minutes. Test ok. Reduced hole to 7 7/8" at 373' and resumed drilling.
