DETAILS OF WORK

Propose to: Set 90' of 8 5/8" casing and cement with 100 sacks cement. Drill through Pictured Cliffs formation to a total depth of 2300' and cement 4 1/2" casing at 2300 with 100 sacks cement. Run logs, perforate Pictured Cliffs formation with 4 shots per foot, and sand-water free with 40,000 gallons water and 60,000 lbs. sand. Run 1" tubing to 2250'.

The NE 1/4 of Section 15, consisting of 160 acres, is dedicated to this location.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

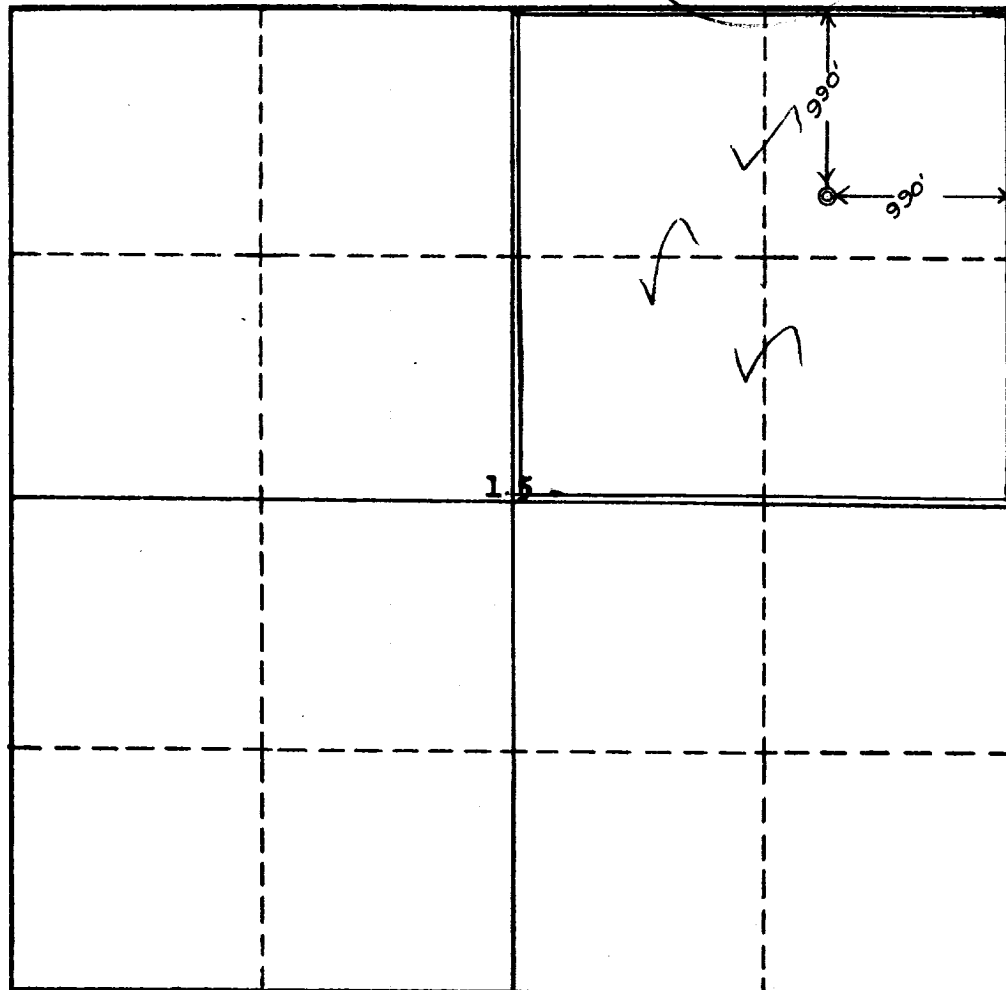
