Drilled sand and shale to 950'. Ran Schlumberger Gamma Ray log 11-18-63. Ran 950' of 5 1/2", 14# production casing. Cemented with 100 sacks cement mixed with 100 cubic feet stratocrete followed by 50 sacks neat. WOC. Perforated Second Dakota with 2 jets/foot 856'-860'. Washed perforations with 20 bbls. water. Ran 2 7/8" tubing, landed at 883'. Swabbed load water, oil. Pulling tubing.

Instructions
