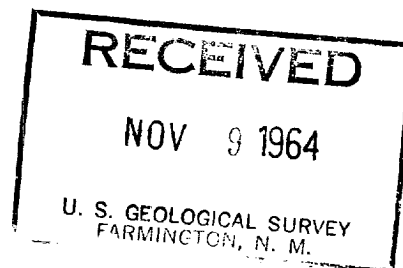
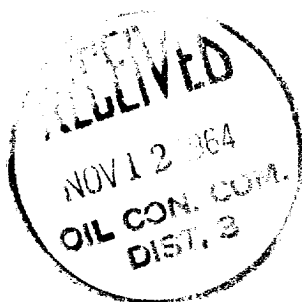

On 11-3-64 total depth 6283'. Ran 192 joints 4 1/2", 10.5#, J-55 casing (6270.82') set at 6282.82'. Stage tools at 4400' and 1855'. Preceded first stage w/FF-50, cemented w/400 sacks of a ratio of 1:1 Diamix "A" and Class "A" cement w/1/4# Cello-flake/sk., and 2% calcium chloride. Second stage w/200 sacks of a ratio of 1:1 Diamix "A" and Class "C" cement w/1/8# Cello-flake/sk. Third stage w/200 sacks of a ratio of 1:1 Diamix and Class "C" cement w/1/4 cu. ft. Strata-Crete "6"/sk., and 1/8# Cello-flake/sk.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
