We appreciate greatly your participation and handling of this matter.

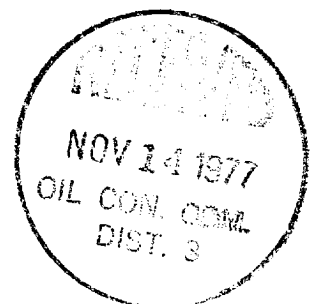
