## DETAILS OF WORK

Well is presently completed open-hole from 6688' to 6810' in the Pennsylvanian. It is proposed to set a Baker Model "C" packer at approximately 6650' and perforate the Perm. "B" formation from 6526' to 6533', 6565' to 6572', and 6575' to 6581'. The Penn. "B" zone will be tested followed by dual completion of the Perm. and Penn. "B" formations. Pennsylvanian oil and gas will be produced through the tubing and Penn. "B" gas will be produced through the casing-tubing annulus.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
