This well was recompleted in October, 1963, in the Pennsylvanian "F" gas zone. A model "D" packer was set @ 6662' to isolate the lower Pennsylvanian "CD" oil zone for dual completion. The "F" zone was perforated from 6326'-6332' and 6565'-6572'. Commercial gas production from the "F" zone was not obtained. It is proposed to squeeze the perforations in the Pennsylvanian "F" zone with cement, drill out the cement and Model "D" packer and return the well to production from the original Pennsylvanian "CD" oil zone. The "CD" oil zone is an open-hole section from 6688'-6816'.

Instructions
