DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudlogging jobs, cementing points, and all other important proposed work)

We propose to drill this well with rotary tools to an estimated depth of 6700' to test the Paradox formation. Approximately 300' of 13 3/8" O.D. surface casing will be set and cemented to surface. Approximately 4500' of 8 5/8" O.D. intermediate casing will be set and cemented. A stage collar will be located at approximately 1000' to cement the Dakota formation. A 5 1/2" O.D. liner will be set and cemented from approximately 4500' to 6600'. The well will be completed open-hole from the bottom of the 5 1/2" O.D. liner to a TD of approximately 6700'.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

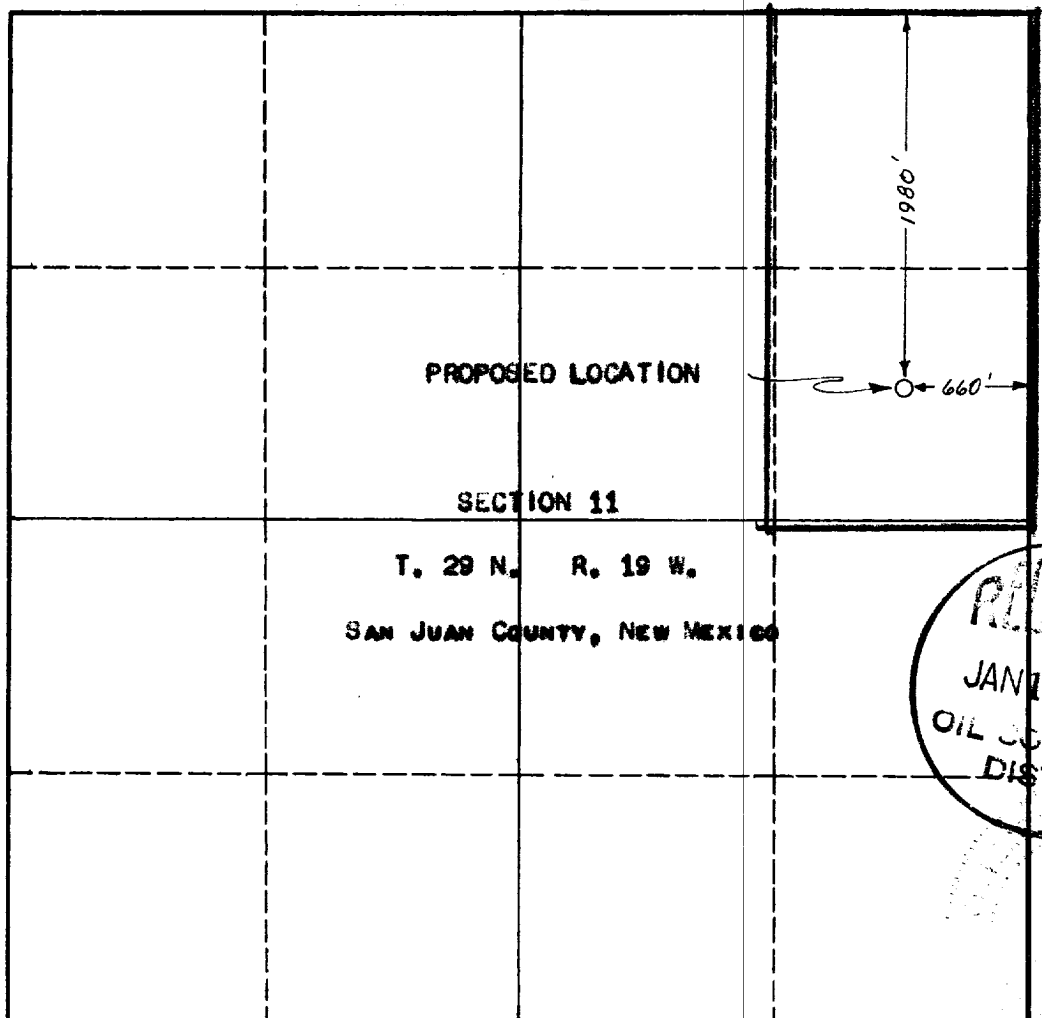

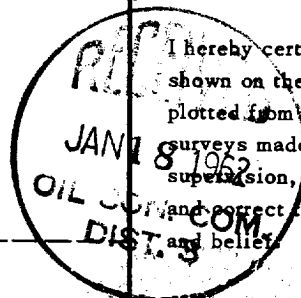
