The subject well is to be plugged and abandon pursuant to the following procedure:

- 1) Move on locatin and rig up. Circulate the wellbore clean.
- 2) Spot a 170 sx (200.6 cu.ft.) cement plug from 3750 to 4680': to cover the Mesa Verde formation. W.O.C. 6 hours.
- 3) Spot a 23 sx (27.14 cu. ft.) cement plug from 2250' to 2370' to cover the Pictured Cliffs formation.
- 4) Perforate 4 squeeze holes 55' below the top of the Fruitland formation @ 2050'. Spot a 50 sx (59 cu. ft.) cement plug. Pressure displace 14 sx (16.5 cu. ft.) into the squeeze holes. Leaving a cement plug inside and outside the casing from 1945 to 2050'. W.O.C. 6 hours.
- 5) Perforate 4 squeeze holes 58' below the top of the Ojo Alamo formation @ 1150'. Spot a 40 sx (47.2 cu. ft.) cement plug. Pressure displace 15 sx (17.7 cu. ft.) into the squeeze holes. Leaving a cement plug inside and outside the casing from 1040' to 1150'. W.O.C. 6 hours.
- 6) Perforate 4 squeeze holes 51' below the base of the surface pipe. Circulate an 85 sx (100.3 cu. ft.) cement plug back to the surface. Leaving the production casing and annulus full from surface to 225'.
- 7) Cut off wellhead and install dryhole marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
