propose to rig up workover unit, circulate out mud and water, clean out to T.B., 6620', pull 1" tubing, pick up Hovco Model "G" production packer, go in hole with packer + 240' (5 joints) tail pipe below, spot 50 barrels of heavy, thick, residual oil with Ken-pac chemicals added down back of tubing. Set packer " 6370", land do-nut in casinghead, squeeze 20 more barrels into formation out through holes in casing, get 10000 squeeze pressure or pump in more heavy oil, set tubing in bonnet, swab well off, reacidize if necessary & release rig. Baker 2-stage tool has been run 3289' with cement circulated to surface

## Instructions
