8-2-78 Spotted 12 sx cmt plug across perms 4220-4330', using Class A cement with 3% CaCl₂. Pulled tubing to 980'. Shut in csg and packed off head. Mixed and pumped 12 sx Class A cement with 3% CaCl₂. Displaced tbg and 4½" csg to 1700'.
Left csg shut in overnight.

8-3-78 Went in hole with tbg to tag top of plug #2. Plug not in place, cement did not set up. Came out of hole with tbg. Tied on to 4½" csg. Pumped 25 Bbls of fresh water. Mixed and pumped 17 sx of Class A cement with 3% CaCl₂. Displaced csg to 1600'.
Left csg shut in overnight.

8-4-78 Went in hole with tbg, tagged cement @ 1598' and came out of hole with tbg @ 160'.
Mixed and pumped 13 sx of Neat cement. Circulated cement and shut in csg.
Mr. John Brimhall, Fruitland, landrepresentative, requested the dry hole marker be left above ground. Screwed 4' dry hole marker on top of csg, well location cleaned, pits filled, surface restored to satisfaction of Mr. Brimhall. Abandoned well site ready for inspection.
