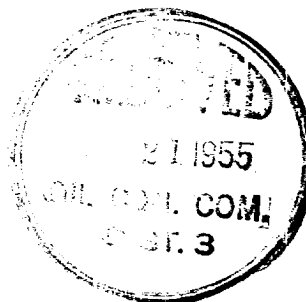

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

On October 12, 1955, 5½" casing was landed at 5003' with 130 sacks cement. After waiting on cement 36 hours, casing and water shut off were tested with 1000# for 30 minutes with no drop in pressure. Drilling operations were resumed.
