A blind plate will be installed, at the surface to prevent gas sales. All production equipment associated with the Fruitland Coal will be dismantled. Amoco plans to use the well as a pressure monitor well for the Fruitland Coal. If the well shall no longer be used as a pressure monitor well, the coal horizon will be plugged and Abandoned at that time. From this point forward the Florance "H" #3 will become the producing well for the coal horizon for the 320 spacing unit.
